## PUBLIC SAVED FROM BALLOONS


### *UC Captain Beckford Destroys Potentially Lethal Balloons with Manly Overhead Ballpoint Pen Strike; Onlookers Swoon with Admiration*

University of California Police Captain Guillermo Beckford thrilled onlookers at the stadium tree-sit by almost singlehandedly wrestling a large, threatening bunch of circus balloons to the ground and stabbing them with a

ballpoint pen, leaving the battleground scattered with small, wet pieces of colored rubber.

"We came from Truckee to see this," said a uniform-clad group of female basketball players near the barricades. "We feel so fortunate we saw the \$700,000 police action in person. We have a more tolerant attitude toward balloons in Truckee, but the confrontation was very exciting."

Tree-sit supporters claimed that the police were unnecessarily brutal to the balloons, which were apparently attending their first protest and "didn't deserve to die", according to one tear-stained witness who plans to file a complaint.

# Frequently Asked Questions Concerning New Cell Phone Laws

**Q: May I use the hands-free feature while driving if my car has the feature built in?**






# PUBLIC SPEWS TOXIC SLUDGE IDEAS

fices, predominantly that of the mayor, but including the office of the chancellor of the University of California, the Planning Department, and various city councilmembers.


