"It's creative, to be sure," states Heather L. Weaver, Senior Staff Attorney for the ACLU Program on Freedom of Religion and Belief regarding the case. "But it casually sidesteps primary author James Madison's intentionally clear separation

of church and state considered essential to avoid 'allowing the government to force citizens to conform to the preferred faith of those in power'."

"The court's current majority is comfortable with taxpayer-funded religion," affirmed legal expert Solomon Grimm, of the University of Perpetual Proportion. "And apparently even more comfortable with nine days of island-hopping in a volcanic archipelago on a billionaire Harlan Crow's superyacht staffed with a private chef."

## Hopkins Bike Lane Project Nightmare Averted by City Staff Mutiny



THOSE WHO STUDIED THE HOPKINS BIKE LANE PROJECT PROPOSAL discovered that cars and bikes get along great online, on maps, in photographs and in design software where nobody gets hurt but really sucks in real life where everybody tends to color outside the lines.

A mutiny Berkeley administrators are referring to as a "staffing crisis" has indefinitely postponed the two-way bike lane which promised both head-on collisions and traffic backed-up to Orinda.

Berkeley City Manager Dee Ridley-Williams appeared to agree, noting that the project appears to have produced nothing but "vacancies, project management changes within the Transportation Division, impacts to the Public Works Department, triggering the need for closer review" due to the questions from sharp-eyed neighbors noting fire safety issues and the fact that "additional time and review are necessary

to convey confidence and integrity in the work product to date" before somebody goes postal.

"Everybody is pointing at somebody else," noted another neighbor in wonder. "The current project doesn't meet Fire Department statutory or best practice requirements and state law prohibits road modifications that don't provide safe access for emergency equipment. The bike riders want their bike lanes whether they violate state law or not, and it's as hard to get them to listen as it is to get a Berkeley City Councilmember to call you back."

### **War on Women Confound Experts and Strategists Alike**

"It's like a dog chasing a car that finally catches up to it," noted legal expert Professor Felix Hawstead solemnly assessing the florid landscape of reproductive healthcare set in motion by the current Supreme Court's majority. "They never thought about what to do with it."

The Supreme Court majority's success overturning Roe v. Wade left a patchwork of confusion illustrated best by Elon Musk's euphemism for the explosion of his company's rocket, described to the press as an "unscheduled rapid disassembly."

"They'll sort out federal judges issuing conflicting Food and Drug Administration (FDA), requirements," commented Hawstead. "But imagine health professionals trying to parse whether they can even discuss medical care with patients without be-

ing criminally charged."
"It's worse for patients," added advocate Gail Sabloin whose Texas medical clinic now consists of advising patients to get online, pack a bag, and cross their fingers. "I don't understand how "stand your ground" gun laws can co-exist in the same political landscape as the concept of a government in charge of everybody's uterus.'
