

What to Expect from Arreguin's Glorious, Brand New **Police Accountability Board** much did that cost

Re: Findings and Recommendations in (an actual case involving BPD) Dear (actual person),

I would like to start by extending my sincere apologies for the delayed response to your complaint. We understand the importance of timely communication and regret any inconvenience or distress this delay may have caused you.

I am writing to inform you of the conclusion of the investigation into your complaint filed with the Office of the Director of Police Accountability (ODPA). During the thorough review and consideration of all available evidence, including Body-Worn Camera footage, officer and witness interviews, and pertinent Berkeley Police Department (BPD) policies, our office faced obstacles in being able to complete the investigation in the Charter mandated 120-days timeframe1. Consequently, the decision has been made to administratively close this case.

The determination to administratively close a case isn't taken lightly. It's based on specific regulations and criteria that govern our operations and mandate closure under certain conditions, such as when investigations exceed the stipulated time frames without possibility of tolling or extension under Gov. Code section 3304(d)(2)(D). In your case, despite our best efforts to conduct a thorough investigation, procedural constraints and the complexities involved in coordinating with multiple entities led to unavoidable delays.

We understand that this outcome may be disappointing, and I wish to convey our deepest regrets for any distress or inconvenience this protracted process may have caused you. It is important to note that administrative closure does not constitute a judgment on the merits of the complaint but rather reflects procedural necessities mandated by the governing legal framework.


